A career in marketing and business ownership was excellent preparation for what loomed ahead in a difficult economic climate. The Chestertown shop opened to feature a trunk show line of women's clothing from the collection of New York private label designer Nina McLemore. Traditionally, customers could only view this line four times a year and usually at a private home for just a few days at a time. The small size of Chestertown was a curious location for this fledgling experimental business. There was a positive response from the community and the many visitors to Chestertown's historic downtown. For the

past three years the shop's business and number of designers has increased dramatically to include great new contemporary clothing and accessories. Nina McLemore has remained the principal line in both locations and includes the best of Nina's latest styles plus great values on clothing from the previous collections. The newest location at The Tidewater Inn offers Mimi's Closet a beautiful new space to show off not only clothing, but antiques, collectibles and fabulous works of art that are all for sale. There is now a "special occasion or wedding party line" offered on the Easton store. Both stores have a very helpful and friendly staff of local women who work hard to make sure that each customer has an enjoyable shopping experience. Mimi's Closet enthusiastically participates in many local fashion events and fundraising endeavors.
